**ORDER:-**

In the G.O Rt. 1<sup>st</sup> read above, directions were issued to the Director for Cooperation and Registrar of Coop Societies, Hyd, for appointing the existing elected members of present Management Committees of PACSs/DCCBs and TGCAB as Person-in-charge to manage the affairs of PACSs/DCCBs and TGCAB respectively under Sec.32 (7)(a) of TCS Act, 1964 for a period of six (6) months from the date of completion of their respective tenure or till further orders of the Government, whichever is earlier.

2. In the reference 2<sup>nd</sup> read above, the Commissioner for Cooperation & Registrar of Cooperative Societies, Telangana, Hyderabad has requested for appointment of PICs to all the PACS in the State beyond 14.08.2025 U/s. 32(7)(a)(1) of TCS Act 1964, as it is not possible to conduct elections to them, pending the reorganization of PACSs and DCCBs in accordance with the new Revenue Mandals and Districts.

3. Government after careful examination of the matter and in exercise of the powers conferred under Sec.131 of TCS Act, 1964, hereby direct the Commissioner for Cooperation & Registrar of Cooperative Societies, Telangana, Hyderabad to extend the term of the present Person-In-Charge Committees of all PACSs/DCCBs/TGCAB to manage the affairs of all PACSs/DCCBs/TGCAB in the State under Section 32(7) (a) of TCS Act 1964 till further orders of the Government, subject to para (4) below.

4. Government further direct that in respect of the outgoing Managing Committees who are deemed to be not fit and not suitable for running the affairs of the Society and also who are performing poorly or where they attract disqualification at any level under the provisions of the TCS Act, 1964 and the relevant Rules, the Registrar of Cooperative Societies can appoint other person or persons to manage the affairs of the Societies under Section 32(7) (a) of the Act.

5. The person(s) in charge appointed shall discharge all the functions of the committee and perform all such activities in the interest of the society as specified in the provisions of the said Act, Rules and bye laws made under.

4. The Commissioner for Cooperation & Registrar of Cooperative Societies, Telangana, Hyderabad shall take further necessary action in the matter.
