O R D E R:

In the reference 2nd cited, the Government have relaxed the ban on transfers of employees during the period 01.05.2026 to 31.05.2026 and issued certain guidelines and as per para 8 of the said G.O, the Transport Department shall make general transfers as per the guidelines issued by Govt in G.O 1st cited.

Consequent to the abolition of Check posts in Transport Department, the Govt vide reference 3rd cited have issued orders redistributing the available MVI/AMVI posts among the (33) districts in the State taking into consideration the vehicular strength/workload, collection, geographical area and the number of Transport Offices functioning in each district.

Further, vide reference 4th cited, the Government have permitted Transport Department to adopt 01.04.2026 as the cut-off date for reckoning the minimum period of service for General Transfers-2026 duly following the guidelines issued in references 1st and 2nd cited and vide reference 5th cited, the Government have issued certain further guidelines.

In terms of the orders issued by Govt vide references 1st to 5th cited and approval of the Committee vide reference 6th cited and based on the options exercised by the individuals, the Transport Commissioner hereby transfers and posts the officials of the cadre of Motor Vehicles Inspectors and Assistant Motor Vehicles Inspectors on request/administrative grounds as mentioned in **Annexure I (MVIs of Multizone I), Annexure II (MVIs of Multizone II), Annexure III (AMVIs of Multizone I) and Annexure IV (AMVIs of Multizone II).**

All the District Transport Officers in the State are requested to take necessary action to implement the orders and report compliance.
