Sub:-Kindly enquiry the matter and forthwith register a criminal case under the appropriate provisions of the BNS, 2023 & the IT Act, 2000 against the culprit, **Sri Kondapalli Ganesh, S/o. Koteswara Rao, R/o. Yellandu (Mobile No. 9666777775)** - The culprit has launched a premeditated, malicious, and unlawful campaign against me by repeatedly transmitting severe threatening & blackmailing communications to my official WhatsApp number, broadcasting fabricated and defamatory allegations to destroy my character & reputation across digital and social media platforms - These intentional & illegal acts directly obstruct a public servant in the discharge of official duties, constitute grave offences of criminal intimidation, extortion including extortionary threats, criminal defamation, transmission of abusive electronic content, & cyber harassment - Hence, I urge swift criminal action by registering criminal case & thorough investigation & restrain the culprit and prevent further irreparable harm to my safety & reputation - Request - Reg.

3. The Culprit, in order to blackmailing & threatening me & he forwarded Two (2) false complaints to my WhatsApp, dated **09.08.2026** at **09:36 AM**.
4. The Culprit, in order to blackmailing & threatening me & he also forwarded Telugu text message to my WhatsApp, dated **09.08.2026** at **10:46 AM**.

5. The Culprit, in order to blackmailing & threatening me & he forwarded an Audio clip (01:31 min) that "ACB verification started" to my WhatsApp, dated **09.08.2026** at **08:56 PM**.
6. The Culprit, in order to blackmailing & threatening me & he forwarded Nine (9) abusive/obscene Telugu text messages to my WhatsApp, dated: **10.08.2026** at **00:12 AM** (subsequently deleted by sender).
7. The Culprit, in order to blackmailing & threatening me & he forwarded Six (6) false representations & dispatched to higher officials, & same was forwarded through my WhatsApp on **10.08.2026** at **00:28 AM**.
8. The Culprit forwarded a Signature Studios video clip (10m 57s) to my WhatsApp, dated **11.08.2026** at **00:50 AM**.
9. The Culprit forwarded a Newspaper clipping & Telugu text message to my WhatsApp, dated: **11.08.2026** at **01:25 AM & 01:28 AM**

I would like to submit few facts for your kind consideration and favourable action solicited.

It is stated that, I, **Vustala Somireddy**, S/o. Anthi Reddy, aged about 53 years, permanent resident of Bakkamanthula Gudem Village, Mathampalli Mandal, Suryapet District, and presently I am serving as Deputy Commissioner, Prohibition & Excise, Khammam Division, I am assumed charge as Deputy Commissioner, on **25th June 2026**.

It is further stated that, the culprit, Sri Kondapalli Ganesh, S/o Koteswara Rao, R/o Yellandu (Illendu), Bhadradi Kothagudem District, operating through Mobile No. +91 9666777775, harbors deep-seated personal malice & vengeance against me. Moreover, the culprit launched a premeditated, malicious, & illegal campaign against me. **Between 08.08.2026 to 11.08.2026**, the culprit repeatedly bombarded my official WhatsApp number (+91 8712658833) with illegal threats, blackmailing communications to my official WhatsApp number by extortion including extortionary threats, criminal defamation, transmission

of abusive electronic content, & cyber harassment, defamatory media interviews, false & blackmailing complaints, and obscene messages.

It is further stated that, in his communications, the culprit falsely alleged that **"I colluded with the Yellandu Circle Inspector of Police and the local MLA to forcibly transfer his licensed liquor shop to one Vadiala Chitti Babu"**. This allegation is factually impossible & fabricated & concocted story, as current retail liquor licenses were allotted via **public lottery** on **01.12.2025**, fact remains, I assumed charge in Khammam Division as Dy. Commissioner, only on **25.06.2026**. Therefore, question of favouring by metosomeneone, it's nothing but false & invented for the purpose of blackmailing & extortion. Moreover, under the governing provisions of the Telangana Excise Act & its statutory rules, **"a retail shop allotted to an individual via lottery only, its neither legally be transferred to another person, nor does the Deputy Commissioner possess statutory power to execute such transfers."**

It is further stated that, on **09.08.2026 at 08:56 PM**, the culprit sent a 01:31-minute audio clip followed by a text reading **"ACB verification started"**, which is a direct, calculated attempt to blackmail, threaten, & intimidate a public servant. Past midnight on 10.08.2026 at 00:12 AM, culprit posted nine (9) obscene Telugu text messages abusing me in vulgar language, which culprit deleted shortly after using the **'Delete for Everyone'** option. Furthermore, to ruin my moral integrity, professional standing, & public reputation, the culprit intentionally & deliberately & widely circulated these false claims across digital media platforms, including broadcast interviews on BRK TV (received 09.08.2026 at 01:18 AM) and Signature Studios (received 11.08.2026 at 00:50 AM), unauthorizedly using my official photograph.

It is stated that, to mislead state machinery and vilify my prestige among superiors, the culprit forwarded copies of these false & frivolous allegations & corruption petitions forwarded to all heads of the state

including ACB and same copies was forwarded to my official WhatsApp. It is further stated that, the continuous threats, public vilification, cyber harassment, & submission of false petitions by the culprit have caused severe mental agony and distress, deliberately obstructing me from discharging my official enforcement duties effectively, disturbing my concentration, & lowering my prestige among superior officers, subordinate staff, and the general public.

It is further stated that, the systematic, deliberate, and malicious acts of the culprit constitute severe, cognizable, & non-bailable offences under the criminal laws & IT laws of the land. By executing a targeted campaign of threats, cyber harassment, and character assassination, the culprit has wilfully used criminal force and intimidation to deter a senior public servant from discharging official statutory duties, engaged in widespread digital defamation, attempted blackmail under the guise of anti-corruption verification, transmitted vulgar & abusive content electronically & intentionally submitted false & fabricated allegations to constitutional & statutory state authorities to mislead public administration.

In view of the above-mentioned facts and circumstances, I request your good office to:

- a) Register a criminal case immediately against Sri Kondapalli Ganesh (Mobile: +91 9666777775) under the appropriate penal provisions and Information Technology laws.
- b) Conduct a thorough criminal investigation & seize the electronic communication devices & mobile phones used to transmit the threatening and defamatory content.
- c) Initiate immediate legal steps to direct the takedown of all defamatory interview videos and posts from YouTube and digital platforms (BRK TV, Signature Studios, etc.).

- d) Take strict penal and preventive legal action against the culprit to ensure the unhindered discharge of my official public duties & safeguard my personal safety and reputation and do the needful.
